

GUIDELINES "CITIZEN OF THE YEAR" NOMINATION

The purpose of the "Citizen of the Year Award" is to recognize the man or woman of the Beaver Valley who has made the greatest all-round contributions to Citizenship. We appreciate your interest in the support of this important award. The name of all nominees will be kept confidential and only the nominee selected by the judges will be announced to the public. The "Citizen of the Year" will be honored during the May Days celebration.

For your guidance we list the few simple regulations governing nominations for the "Citizen of the Year Award".

1. A group or individual may submit ***ONE OR MORE*** nominations.
2. A nominee should be one who has made outstanding contributions in:
 - ***Community Service***
 - ***Cultural Activities***
 - ***Recreation***
 - ***Civic Service***
 - ***Youth Work***
 - ***Religious Activity***
 - ***Community Promotion, etc.***
3. A suggested nomination form is attached on the backside of this form. It is important that you list for the judges the qualifications that prompt you to make a nomination.
4. A nominee must be a resident of the Beaver Valley since, or before January 1, 1994.
5. Candidates can be nominated posthumously.
6. Permission of your nominee is not required prior to your nomination. The nominee's permission will be obtained before the "Citizen of the Year Award" is presented.
7. Nominations must be received deadline date and time.
8. Nominations become the property of the "Citizen of the Year Award" Committee.

The Judges will consider all nominations and their decision will be released shortly thereafter. A public function for the presentation of the Award will be held on the Friday night of the May Days celebrations.
