POLICY 6.06

POLICY TITLE: CHANGE OF STREET NAME TO A PERSON'S NAME

PURPOSE OF POLICY:

To provide a guideline on the procedures to change the current name of a Village of Fruitvale street to the name of a person.

The following guidelines must be met in order to change a current street name to a person's name:

- The proposed street name must have an historical significance in the Village of Fruitvale and the attached questionnaire must be completed and submitted to the Village Office;
- The Village Office will send letters to the residents on the affected street and any objections must be submitted in writing to the Village Office within a timely manner.
- There must be an agreement by at least 80% of the property owners on the street to which the name change is proposed;
- Any proposed change must be adopted by motion at a Council meeting.
- Council will not consider any changes to streets that are currently named after a person.**

Village Office staff will inform the Utility Companies (ie: gas, electricity, telephone, cable), BC Assessment, Land Titles and the Regional District of Kootenay Boundary of the street name change once the change is adopted by Council.
